Article. 1 - The contract is valid for **one year** and the minimum contribution is **60 €** for 1olive tree. If the initiative has been satisfactory, the adopter will have to explicitly express his/her wish to renew the agreement, by subscribing to a renewed adoption agreement. It is possible to adopt several olive trees.

Article. 2 - The Farm is committed to inform the adopter, by e-mail, on all treatments linked to cultivation made on the adopted plant.

Article. 3 - The Farm offers the adopter the chance to visit the adopted tree, to assist in the harvest and to take part in guided tours.

Article. 4 - The adopter is entitled to choose among the following:

- one 5 l. tin of organic extra virgin olive oil
- four 1 liter bottles of organic extra virgin olive oil
- five 0.75 l. bottles of organic extra virgin olive oil
- six 0.50 l. bottles of organic extra virgin olive oil

Moreover, as free sample : a bar of olive tree flower soap and samples of the farm's dried herbs

The shipping will be at the cost of the adopter.

Article. 5 - Payment conditions are as follows: bank transfer to the beneficiary (Merciai Annalisa Farm, owner of the plant) on the bank account that the beneficiary agrees to send the adopter at the time of receipt of the signed contract. The subscription of the agreement made directly or sent by e-mail at the address in the header, will be considered as reading, approval and signature of all articles of the contract by both parties. It will be binding on the applicant from the date of transmission, and for the Farm at the time of receipt of the subscription and the bank transfer.
